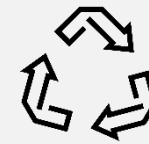

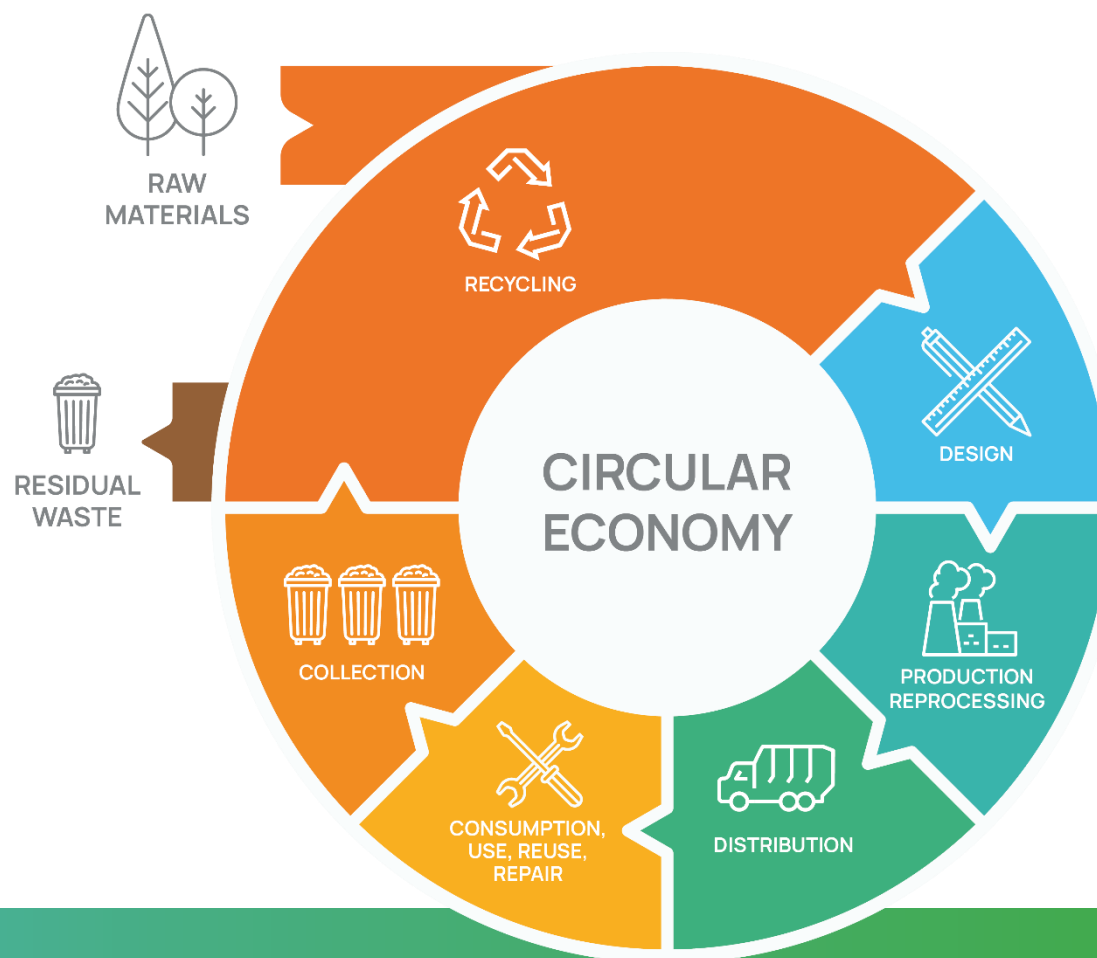

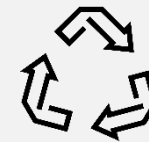


La Lucente Ecologia is a subsidiary of La Lucente SpA, a national leader in integrated facility management and a historic brand of national interest.

- Sale



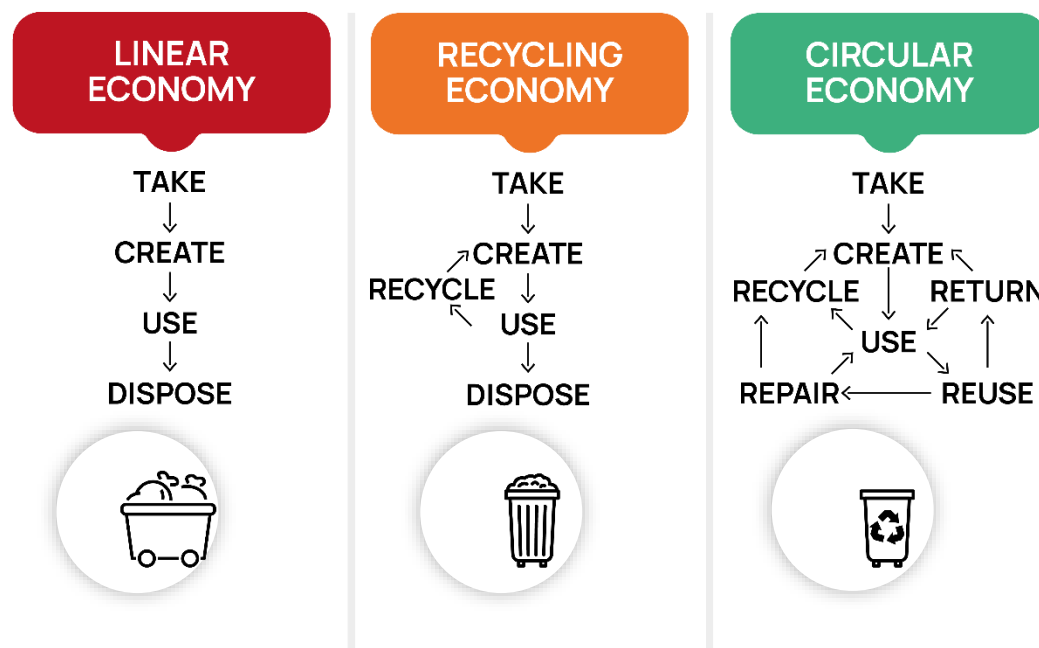


LA LUCENTE ECOLOGIA / Your partner for the circular economy

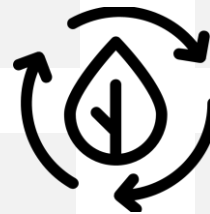

Collection and transport of hazardous and non-hazardous waste

To carry out waste collection, La Lucente Ecologia employs specialised staff and specially equipped vehicles.

Intermediation and/or waste trading

La Lucente Ecologia acts as a link between the producer/holder of the waste on the one hand and the final recipient on the other. It works to ensure the best environmental and economic waste management for the producer.



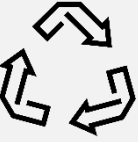
Grouping, waste handling and temporary storage management

La Lucente Ecologia also provides a comprehensive service directly at the manufacturers' premises: prior to disposal, it sorts the waste, handles it, labels it and packs it into homogeneous categories.

For waste producers, La Lucente Ecologia provides consulting services to ensure compliance with current legislation, including compliance with RENTRI – the National Electronic Register for Waste Traceability, referred to Ministerial Decree no. 59 of 4 April 2023.

La Lucente Ecologia carries out waste removal work, including in cases of illegal dumping.

LA LUCENTE ECOLOGIA / Destruction of confidential archives



La Lucente Ecologia carries out the destruction of confidential archives, including on-site shredding and subsequent transport to an authorised facility.





LA LUCENTE ECOLOGIA / Management of temporary waste storage

Within a major production plant belonging to a well-known national group, La Lucente Ecologia provides services for the **handling of waste, grouping and management of temporary storage of waste** (hazardous and non-hazardous).

La Lucente Ecologia's suitably trained and qualified staff collect the waste produced within the plant in a differentiated manner, moving it from nearby containers and placing it in 25 cubic metres containers.

These containers are picked up by a truck equipped with roll-off equipment and taken to the temporary waste storage facility, where the waste is sorted, also with the aid of a hydraulic loader, labelled and stored separately.

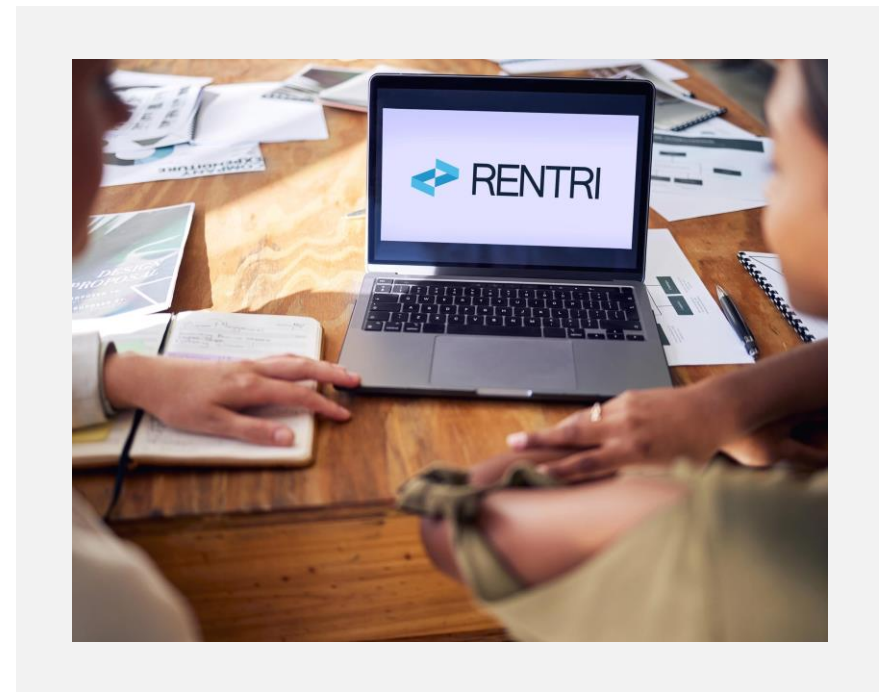


LA LUCENTE ECOLOGIA / Environmental Consulting



For waste producers, La Lucente Ecologia provides consulting services to ensure compliance with current regulations:

- **Environmental training** aimed at transferring the specialist skills needed to manage waste efficiently, effectively and in compliance with regulations.
- **Compliance with RENTRI** – the National Electronic Register for Waste Traceability, pursuant to Ministerial Decree no. 59 of 4 April 2023: issuing and completing forms, completing the digital waste loading and unloading register, transmitting the register to RENTRI, digital signature and digital storage of documents.
- **Preparation and electronic submission of MUDs.**
